RULES AND REGULATIONS

1. No donation or purchase is necessary to enter or win. (A purchase or donation will not increase your chances of winning.)
All entries must be received by June 20, 2010

2. **ELIGIBILITY:** Story Search is open to all individuals who live, work or volunteer in Midland County. Minors under the age of 18 must have parental consent to enter the contest. Employees of United Way of Midland County (UWMC) are not eligible to enter.

CHILDREN AND MINORS: Consistent with the Federal Children's Online Privacy Protection Act of 1998 (COPPA), we will never knowingly request personally identifiable information from anyone under the age of 13 without requesting parental consent. Any entrant who is a minor in his/her jurisdiction of legal residence will be required to obtain the permission of his/her parent or legal guardian to participate in this Contest. Entrant must also have obtained all necessary permissions from anyone else featured in his/her Submission, including permission from parents or legal guardians of minors included in such Submission (written proof of such permission must be made available to UWMC upon request).
